(First Party and Second Party are here in after jointly referred to as "Parties" and individual as "Party") as
WHEREAS :

- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities

- D) Both Parties being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS,

CLAUSE 1

CO-OPERATION

Both Parties are united by common interests and objectives and they shall establish channels of communications and co-operation will promote and advance their respective operations within the institution and its related wings. The parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

First Party and Second party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching /training systems, keeping in mind the needs of the Industry, the second party.

The general terms of co-operation shall be governed by this MOU. Parties shall co-operate with each other and shall as promptly as is reasonably practical, enter in to all relevant agreements, deeds and documents as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents this MOU shall represent the entire understanding as to the subject matter and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2

SCOPE OF THE MOU

Placement of Trained Students : Second party will actively engage to help the delivery of the training and placement of students of the First party into internship/jobs and will facilitate Placements for the students . The Second party will itself absorb the trained students.

Both Parties to obtain will internal approvals, consents permissions and licensed of whatsoever nature required for offering the programmes on the terms specified here in.

There is no financial commitment on the part of the Shree Vidyadhiraj Polytechnic, KUMTA, the First party to take up any programme mentioned in the MOU

CLAUSE 3
INTELLECTUAL PROPERTY

Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either party any right, title, interest or license in or to the intellectual property of the other Party.

CLAUSE 4
VALIDITY

Both parties may terminate this MOU upon 30 calendar days notice in writing. In the event of Termination, both parties have to discharge their obligations.

RELATIONSHIP BETWEEN THE PARTIES




